The data obtained from the survey is analyzed by the school's ABAV Committee. The Committee then determines which programs will be put in place to support students.

There was no report.

5.3 Parents' Committee Report

On Dec 12th PC held a special meeting to discuss the new school project in St-Lin. It was brought to our attention that the Ministry of Education would not provide additional funding (around 18M) to begin and complete the new school.

The school board received a letter from the Ministry which stated that the amount needed for the school exceeds what was originally requested when the project went to tender. The Ministry recommends that SWLSB wait until prices go back down to begin this project.

SWLSB doesn't agree with this recommendation as the prices NEVER go back down once a company or industry realizes that they can charge for more a good or service. Additionally, not building this school will continue to put a strain on the 6 schools in the St-Lin area which are already operating above the Ministry's capacity per school. The schools have had to resort to temporary building which cost a lot, wear down quickly, and require students to get fully dressed in the winter to travel from inside the main school building to these temporary buildings. All this in turn will end up being more costly to the Ministry than providing the additional funding. Not only this, but the territory in St-Lin and the commute to school can be measured in hours rather than minutes due to rezoning students to try to alleviate some of the strain on the surrounding schools.

During the meeting many questions were asked to the Commissioners from the parents of PC. One of the main questions was why did the board not go to the media with this and the question was slightly avoided which makes some of the parents in attendance to believe that the board dropped the ball somewhere. Although, the board may be partially at fault, we still think we need the additional school and passed a resolution to have the Council of Commissioners submit to the ministry on our behalf, on top of that, we created a subcommittee to write our own letter and submit it.

It is clear to PC that there must be a new school in St-Lin. We also fear that if we allow the Ministry to back out of this school that they will also back out of the other schools that SWLSB have plans to open in the next few years.

5.4 Home & School Association Report

Our last meeting for Home and School was held on November 29th, 2022.

We had the Epicure fundraiser ending and 22 boxes were sold.

In total we made 281\$ which has already been deposited in our account.

The Adopt-A-Tree campaign has started. We are currently in the process of working with Mr.

Gray to get new tags that are more durable for our harsh weather.

A quote has been sent for tags and an engraving machine.

Teacher appreciation week is February 6-10, Costa will be creating in December a flyer to request donations from the parent community.

Marnie was able to get our school "a partnership" with the SPC card.

This card gives students discounts to various stores for only 10\$ membership/year.

Students must be 13 and over.

School gets 3\$ for every card purchased.
