**0. Opening of the meeting / Quorum:** The meeting was called to order by Jenny Georgiopoulos at 7:10 pm. Quorum was met. The acknowledgement of the land was read in English by George Dimacacos and in Mohawk by Michael Rice.

"The Sir Wilfred Laurier School Board is on land which is traditional territory of the Kanien'keha:ka or Mohawk Nation. The Mohawk Nation is also known as the 'Eastern Door Keepers' and are a member of the Haudensaunee Confederacy, which also includes the Seneca, Cayuga, Tuscarora, Onondaga, and Oneida Peoples. All those who gather here are counted as esteemed stakeholders in our community and most importantly friends."

It was agreed that the letter would be written by Jenny Georgiopoulos, who would then share it with the members, before submitting it to the SWL board.
