0. Welcome / Verification of Quorum / Acknowledgment of the Land: The meeting was called to order by Jenny Georgiopoulos at 7:09 pm. Quorum was met. Nina Rodrigues was replacing an absent parent member. The acknowledgement of the land was read in English by Effie Kontakos.

"The Sir Wilfrid Laurier School Board is on land which is traditional territory of the Kanien'keha:ka or Mohawk Nation. The Mohawk Nation is also known as the 'Eastern Door Keepers' and are a member of the Haudensaunee Confederacy, which also includes the Seneca, Cayuga, Tuscarora, Onondaga, and Oneida Peoples. All those who gather here are counted as esteemed stakeholders in our community and most importantly friends."

3.0 Business Arising:

3.1 E-votes since the last GB Meeting:

3.1.1 E-vote – École Montreal Holocaust Museum Field Trip: The e-vote was on November 15th for a field trip to the Montreal Holocaust Museum is scheduled for March 21 and 22, 2024. This trip ties in with LJA's French Second Language and English Language Arts curricula, in connection with our educational project for the month of March. Sec. 1 and Sec. 2 students will be given a guided visit of the museum and a history and writing workshop This field trip will allow students to read and hear stories of the Jewish community, experiencing the role language, writing and documents played during the WWII period, as they have rich conversations with the curators of MHM, a well-known repository of history and culture in Montreal. The cost of the activity is \$25. Transportation by school bus. This trip will be subsidized by the Measures. Departure from school at 8:30 am and return at 2:30 pm. In light of the current international situation, there are concerns regarding the safety and security of the students. In February, a final decision will be made as to whether the trip will take place upon considering the safety and security of the students.

- **3.2 Community Representatives:** The members were informed regarding the requirements for Community Representatives. A Community Representative is not allowed to vote and is appointed by the other members of the Governing Board. Spyridonas Pettas was considered as a candidate to join the Laval Junior Academy Governing Board. If there are concerns regarding a potential Community Representative, they should be expressed before their appointment as a Governing Board member. The only requirements are the following:
 - that Community Representatives are not members of the school staff;
 - they must disclose any direct or indirect interest <u>in an enterprise</u> that places the member's personal interest in conflict with the interest of the school and must avoid influencing the decision relating to it. The member must, in addition, withdraw from a meeting while the matter is discussed or voted on.

Note: The definition of enterprise is the one found in the Civil Code: "The carrying on by one or more persons of an organized economic activity, whether or not it is commercial in nature, consisting of producing, administering or alienating property, or providing a service, constitutes the operation of an enterprise".

Involvement in politics would not be considered as a conflict of interest in an enterprise.

However, Section 71 of the Quebec Education Act provides that: "The members of the governing board (...) must also act with honesty and loyalty <u>and in the interest of the school</u>, the students, the parents, the school staff and the community", not in their own or their political party's interest.

5.0 New Business

- **5.1 Survey Results & ABAV Plan 2023 2024:** Gloria Cuccarolo presented the survey results and LJA ABAV Plan for 2023-2024. It was reviewed and discussed. Highlights:
 - sense of belonging 65% increase of 8% from last year;
 - positive relationships 81% increase of 6% from last year;
 - anxiety 25% decrease of 7% from last year;
 - depression 16% decrease of 7% from last year;
 - self-esteem 76% increase of 6% from last year:
 - feel safe attending school 41% increase of 5% from last year;
 - bullying, exclusion, and harassment 21% decrease of 3% from last year.

Outcomes that need to be improved are interest & motivation, effort, and self-regulation. The ABAV Plan was presented, revised, and edited. New measures and priorities were put in place. The LJA ABAV Plan will be posted on on the school website. The ABAV Plan was approved by Teacher Council.
